Tax Return Filers - both student and parent(s):

1. Link the 2016 Tax Return Transcript using the Data Retrieval Tool (DTR) by access the student's FAFSA online at fafsa.gov. The DTR is found under the Financial Information section of the FAFSA. Electronically sign and submit the corrected FAFSA to ETBU. This option take 2 business days to be sent to the school.

OR

Request the 2016 Tax Return Transcript at www.irs.gov select "Get Your Tax Record" and then "Get a Transcript (Online or by Mail)." Request a Return Transcript MOT an Account Transcript. This option takes 5-10 business to be mailed to you.

2. Submit the completed form and supporting documents to the ETBU financial aid office.
